Application along with proof of their current credentials (in original and 1 set of Xerox) in single work in proper form and valid certificates of up to date clearance of GST Registration Certificate, PAN Card & Trade Licence from Corporation/ Municipality etc. (Each documents should be in original and one set of Xerox) as applicable will have to be submitted to the Office of the Chairman, Mal Municipality. And failing of which no tender papers will be issued. Submission of Original Certificates in must. Intending tendered may apply and obtain tender papers well in advance to guard against any difficulties due to possible absence from the headquarters of the Chairman and concerned officers. Intending tenderers are request to quote their rates after having been verified the rates with the concerned schedule of rates and site condition well in advance. No unauthorized person will be allowed to apply, purchase and to drop tender form. All documents will have to be submitted with a (i) Self attestation with a certificate as "Produce by me" on each document, (ii) Submission of NO OBJECTION Certificate from A.R.C.S. in case of Engineering Co-op Society is must. Percentage rate (At per/ less/ above) than the estimated cost put to tender should be quoted both in figure as well as in words. Any tender paper which does not fulfil any of above condition or becomes incomplete in any respect shall liable to be rejected. Contractors, failing to submit the tender documents in the tender box, will not be allowed to participate in next two consecutive tenders in whom he will submit application accordingly.
